FINDS:

That the Board of Directors of said District has served without compensation since its organization;

That 37-45-115 (3) C. R. S. 1973, authorizes the Court to set the compensation of the members; that the members should be compensated for attending meetings of the Board; therefore,

IT IS ORDERED That effective with the regular meeting of July, 1976, each member of the Board of Directors of the said District shall be entitled to receive as compensation for his service the sum of \$25.00 for each meeting attended, together with mileage at the rate of twelve (12) cents per mile,



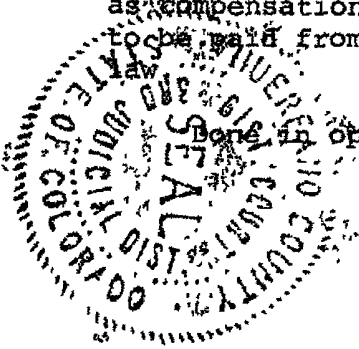
FINDS that \$50 per month would be reasonable compensation for the members of the Board of Directors, therefore,

The Huerfano County Water Conservancy District having filed a petition to increase the compensation of the board of directors, and the Court having read the petition, examined the files herein and being fully advised, finds that \$1,200 per annum, payable monthly, would be reasonable compensation for the members of the board of directors, therefore,

IT IS ORDERED:

Good cause appearing, hereafter, each board member of the Huerfano County Water Conservancy District shall receive as compensation for his services, One Thousand Two Hundred Dollars per annum, payable monthly, together with necessary traveling expenses actually expended while engaged in the performance of his duties pursuant to the provisions of Section 37-45-115 C.R.S..
