HUERFANO COUNTY WATER CONSERVANCY DISTRICT

Minutes of Board Meeting September 30, 2019

The monthly meeting of the Huerfano County Water Conservancy District was called to order by President Scott King at Walsenburg Housing Authority on Monday, September 30, 2019 at 6:00 pm.

Directors present: Michael "Sandy" White, Scott King, Kent Mace, Lonnie Brown. Secretary: Carol Dunn; Attorney: Steve Monson Guests: Rick Dunn, Doug Brgoch, Brian Lalander.

The agenda was approved.

<u>MINUTES</u> – White moved and Brown seconded to approve the August 19, 2019 minutes as presented. Board approved.

<u>TREASURER REPORT</u> – White moved and Brown seconded to approve the Treasurer's reports. Board approved.

Dunn presented the draft 2020 budget to the board. White suggested increasing the budget for director fees to \$2,400 per year and budget \$2,000 more for state level meeting attendance for board members. King suggested board members let Dunn know of any other recommended changes. The budget will be published for public inspection after the October 28 board meeting.

OLD BUSINESS - None.

NEW BUSINESS -

It was decided **no action** will be taken on the Tres Valles Ponds water case 2019CW3054.

Water Commissioner Brgoch reported the Huerfano River flows are at 15 cfs and the call is #13. Cucharas River flow is six feet at the upper reach, and the call is #3. He said this is the first September he can remember when this area hasn't had any measurable precipitation. Brgoch explained his recollection about the HCWCD Advisory Board, which included representatives of local farms, ranches, municipalities. Their expertise may be needed, useful and valued by the board; they would not vote.

Brgoch reported the channel protection work on Middle Creek started today. Frontier Environmental will do the work for just over \$134,000. Town of La Veta will bill HCWCD for up to \$4,500 to cover the match needed, as agreed at the August meeting.

Infrastructure improvements project: The final planned weir/gage will be installed on Herman Wooten's land on the lower Huerfano by Chaparral Construction in October. Brgoch will send permission documents again for the final monitoring well at Cucharas #5 reservoir, this time to a legal firm in Denver, which is now the Two Rivers W&F contact. The plan is to finish the well and gage by 12/31/19.

Carol Dunn presented a summary of Huerfano Water Day. White **moved** and Brown seconded to give Dunn a \$1,000 one-time bonus for the extra work she did coordinating Water Day. Board approved.

A strategic plan workshop was scheduled for Friday February 21, 2020 from 10-4, lunch included. Suggested attendees included Bill Tyner, his staff, Mark Perry, and others. White will develop a list.

Change order #3, extending the schedule on SMAF to October 29, was approved on a White/Mace **motion**.

The 2019 amended bylaws were adopted on a White/Brown motion.

King administered the oath of office to renew the board member terms for White and Brown.

C9 Summit – King reported that during the conference, discussions were held about where water will come from to support the increased population in Colorado, which is expected to double by the year 2050. Reservoir projects will be imperative.

At 7:08 King called for a break. At 7:17 meeting was reconvened.

At 9:58 pm, White **moved**, Mace seconded and board approved closing the executive session and returning to open session. The meeting was called back to regular session at 9:58 pm. There being no further business, meeting adjourned at 9:58 pm.
